CONSIDERATION AND ACTION REGARDING AN ORDINANCE AMENDING THE CODE OF ORDINANCES OF THE CITY OF ALVARADO, FOR THE PURPOSES OF DISSOLVING THE PLANNING AND ZONING COMMISSION OF THE CITY OF ALVARADO, ELIMINATING ALL REFERENCES TO THE PLANNING AND ZONING COMMISSION CONTAINED THEREIN, AND ESTABLISHING THAT APPLICATIONS FOR ZONING BOUNDARY CHANGES OR CHANGES TO THE ZONING REGULATIONS SHALL THEREAFTER BE MADE DIRECTLY TO THE CITY COUNCIL.

After discussion, motion was made by Member Mike McBee, duly seconded by Member Beverly Short to deny an ordinance amending the Alvarado Code of Ordinances for the purpose of dissolving the Planning and Zoning Commission, eliminating all references to the Planning and Zoning Commission contained therein and establishing that applications for zoning boundary changes or changes to the zoning regulations shall thereafter be made directly to the city council. This motion supported four votes in approval and zero votes opposed. Motion carried.
